“GROW IN GRACE” – BUILDING PROJECT FUNDS

The three year “Grow in Grace” program wrapped up at the end of May 2017. In April, letters were sent to all congregation members who had not yet completed giving the full amount of their pledge. We have received approximately 90% of the pledged funds along with over \$70,000 in unpledged giving. At the end of the campaign, over \$70,000 of pledged funds had not yet been received.

In consultation with Jeff Newlin, the capital fund consultant, Council has identified that most churches retain their building campaign funds during the first full mortgage year. While Council is confident that the congregation will continue to give (continued)

what they have pledged for 2017, we are considering holding the funds until early 2018 to allow for the utilization of the Building Funds for any mortgage payment shortfall. Any unused funds would then be applied to the loan principal in early 2018.

JOB RESPONSIBILITIES CHANGE – OFFICE MANAGER/DIRECTOR OF INVOLVEMENT

At the April 22nd Council meeting, it was unanimously voted to amend the role and job responsibilities of Lisa Bernd to include oversight of ongoing custodial and cleaning needs of the building. This includes supervision over the Custodial Position. Over time, Lisa had been handling the property coordination and this change will also provide stability in leadership for the custodial role, which had previously been reporting to the Property Chairperson. In recognition of the additional supervisory responsibilities a title change and salary increase was enacted, effective May 1, 2017. The impact to the 2017 budget is estimated at \$1,100.

EMERGENCY PLAN

Council is working to finalize an emergency plan that, once approved, will be distributed to all Committee Chairs, local police department, staff and published on the website. The plan will cover events including tornados, utility outages, fire, active shooter, bomb threats and medical emergencies. More information will be provided in the next few months.


